



**House of Blues Music Forward Foundation
Consent, Release & Acknowledgement**

In consideration of the opportunity for my child to participate in the House of Blues Music Forward Foundation's sponsored programs and/or events, which may include performances at a House of Blues, Live Nation Entertainment, or third-party venue (the "Programs"), I, the undersigned, give my permission for and grant the House of Blues Music Forward Foundation (the "Foundation") the irrevocable right to interview my child and/or record his or her participation in the Programs including to be photographed, videotaped, recorded and/or filmed during and in connection with the Programs, and for the use of any such images, likenesses and/or recordings of his or her voice, conversation and sounds (collectively "Image"). I further grant permission for the use of any submission materials, including application materials and post-activity follow up materials (collectively "Submission Materials"). I hereby grant to the Foundation the unrestricted, nonexclusive, royalty-free, irrevocable, worldwide, perpetual and fully sublicenseable right, in the Foundation's sole and absolute discretion, to use, reproduce, modify, adapt, publish, translate, create derivative works from, distribute, and display Image and the Submission Materials in any manner whatsoever as long as any such alteration does not diminish the integrity of the Image and/or Submission Materials such that it no longer is an accurate representation of me, and to combine the Image and/or Submission Materials with other images, text, graphics, photographs and artwork in connection with promoting, edifying, advertising, publicizing, marketing and merchandising of any product or service of the Foundation, its affiliates and partners. I understand that neither I, my child, his or her or my executors, administrators, personal representatives, assigns, heirs, nor next of kin will receive any monetary compensation for the rights granted herein. I warrant that I am free to grant the rights herein and that the exercise of such rights will not violate or infringe upon the rights of any third party, and I agree to indemnify, defend and hold harmless the Foundation from and against any liability arising out of a third party claim which is inconsistent with this warranty.

In addition, I release, waive, discharge and covenant not to sue or exercise any legal right to seek damages from the Foundation and its board of directors, employees and agents (collectively, the "Releasees") from all liability to me, my child, his or her executors, administrators, personal representatives, assigns, heirs and the next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property, or resulting in death, to the undersigned arising out of or related to my child's participation with the Programs whether caused, in whole or in part, by the sole or concurrent negligence (whether active or passive) or wrongdoing, strict liability or fault of the Releasees or otherwise. I also hereby release the Foundation and the Releasees from any liability to me, my child, his or her executors, administrators, personal representatives, assigns, heirs and the next of kin, based upon or arising out of use of my child's name, likeness or voice, or Image. I agree to make no accounting, monetary or other claim against the Foundation for use of my child's name, likeness or voice, or Image.

For participants in the Bringing Down the House program ("BDTH"), I acknowledge and agree as follows: (i) my child will be assigned a mentor (the "Mentor") by the Foundation to support his or her work during the course of BDTH, and I consent to this mentorship component of BDTH; (ii) my child will meet with his or her Mentor only during designated times and places that are supervised by Foundation staff; (iii) communication with the Mentor outside of the designated places and times referred to in (ii) shall occur only via email, and the participant must copy the designated Foundation staff on all such correspondence; (iv) participants may connect to the Mentor via professional networking sites (e.g., LinkedIn) or through professional platforms (e.g., an Artist's professional, as opposed to personal, Facebook page), but all other social media connections through personal sites is prohibited; (v) I or my child will immediately contact designated Foundation staff if there are any questions or concerns related to BDTH or its mentorship component; and (vi) I have received a copy of the BDTH application requirements and agree to the terms, conditions and rules set forth therein.

This Consent, Release & Acknowledgement shall be governed in accordance with the laws of state where my child's participation in the Programs is located.

I have read the above authorization and fully understand the contents thereof. This agreement shall be binding upon me and my heirs, legal representatives and assigns.

I, the undersigned, am the parent or legal guardian of a participant who is less than 18 years of age. I have read this Consent, Release and Acknowledgement and understand all its terms. I execute it voluntarily and with full knowledge of its significance.
